Gentlemen:

Pursuant to the provisions of 43 U.S.C. S 1744(a) and 43 C.F.R. S 3833.2-3, the undersigned Tenneco Minerals Company (the "Owner"), whose address is 5301 Longley Lane, #113, Reno, Nevada 89511, hereby gives this notice of intention to hold the mining claim(s) more particularly described in Exhibit A attached hereto and incorporated by reference herein.

In compliance with the above-cited law and regulations, the Owner hereby sets forth the following information:

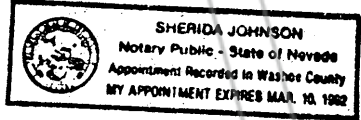
