The work consisted of drilling. The work described above was performed at the following locations: JC # 4.

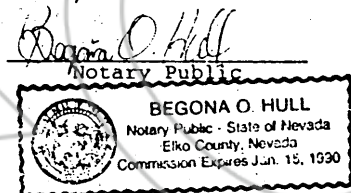
