## CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

That Gregory Gintoff, by and through their lawful and authorized agent, Barry K. Bradshaw, gives notice that he/they claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing their rights, states and certifies as follows:

- The name of the claim is ALB - 12.
- The name and current mailing address of the locator is Gregory Gintoff, 1000 Beck Street, #250, Reno, Nevada 89509.
- The date of location is the 29th day of September, 1988.
- The claim is 1500 feet long and 600 feet wide, such that 1490 feet is claimed in an easterly direction and 10 feet in a westerly direction from the discovery monument, and which the Location Notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is easterly as nearly as may be determined.
