

CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

ECM, Incorporated, by and through its lawful and authorized agent, Patrick C. Cavanaugh, gives notice that it claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing its rights, states and certifies as follows:

1. The name of the claim is KV 629.
2. The name and current mailing address of the locator is ECM, Incorporated, 2720 3rd Ave. North, Suite 450, Billings, MT 59101.
3. The date of location is July 13, 1988.
4. The claim is 1500 feet long and 600 feet wide, such that 20 feet is claimed in a South direction and 1480 feet in a North direction from the discovery monument, and which the Location Notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is North/South as nearly as may be determined.
