QUITCLAIM DEED

THIS INDENTURE, made and entered into this 9th day of August, 1988, by and between Sam Bida and Neva Bida, of 2160 Crawford Street, Ely, Nevada 89301, and Leon Belaustegui and Velma Belaustegui of P.O. Box 393, Battle Mountain, Nevada 89820, herein referred to as the Grantors, and Isabel Kuglmeier, P.O. Box 23520, Tucson, Arizona 85734, hereinafter referred to as Grantees,

WITNESSETH:

That said Grantor, for and in consideration of the sum of Ten (\$10.00) Dollars, lawful current money of the United States of America, to them in hand paid by the said Grantees, and other good and lawful consideration, the receipt of which is hereby acknowledged, has remised, released and forever quitclaimed, and by these presents does remise, release and forever quitclaim unto the said Grantees, their successors and assigns forever, all their right, title and interest in and to those certain unpatented mining claims as designated in a deed to TICUP MINING CORPORATION whereby a royalty interest had been retained and as designated in the contract dated May 9, 1988 to Isabel Kuglmeier on page 3, paragraph A, line 5: "Sam Bida and Neva Bida, husband and wife, and Leon Belaustegui and Velma Belaustegui, husband and wife, have a reserved interest in the mining claims of two percent (2%) of the Gross Smelter Return or one-half (½) of the advance production payments and production payments due to Lessor under this Agreement. Said reserved interest is set forth in a Quitclaim Deed recorded as Document 91517 in the Official Records of Eureka County"; situate, lying and being in the County of Eureka, State of Nevada, and more particularly described in Exhibit 'A' attached hereto and by reference made a part hereof.

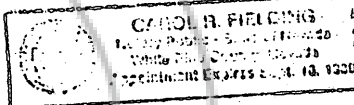

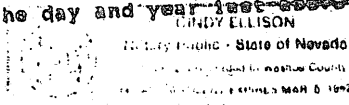
