MEMORANDUM MINING LEASE AGREEMENT

This is a Memorandum of a Mining Lease Agreement dated the 25th day of August 1987 by and between JAMES HOPPER and THOMAS HOPPER day of August 1987 by and between James HOPPER and THOMAS HOPPER hereinafter refered to as "Owner", and GREGORY B. GINTOFF, hereinafter refered to as "Lessee".

1. Lease and Term. 4. Removeal of Property. Lesses may, within one year after termination of this agreement, remove from Owner's real property all property and improvements which he has erected or placed thereon.

5. Additional Terms. Additional terms and conditions are contained in the full agreement between the parties. This Memorandum of Agreement shall not affect said agreement or any rights, interests or obligations of the parties thereunder.
