MEMORANDUM MINING LEASE AGREEMENT

This is a Memorandum of a Mining Lease Agreement dated the 20th day of November 1987 by and between KURT KLAPWYCK, hereinafter refered to as "Owner", and GREGORY B. GINTOFF, hereinafter refered to as "Lessee".

l. Lease and Term. 4. Removed of Property. Lesses may, within one year after termination of this agreement, remove from Owner's real property all property and improvements which he has erected or placed thereon.

Additional terms and conditions are 5. Additional Terms. Additional terms and conditions are contained in the full agreement between the parties. This Memorandum of Agreement shall not affect said agreement or any rights, interests or obligations of the parties thereunder.
