We (or I) claim 150 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 140 feet from the location monument in a North-erly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, N. 90°00'W., 600 feet to the Southwest Corner (Cor. No. 5).  
thence, N. 00°00'E., 75 feet to the West Side Center (Cor. No. 6).  
thence, N. 00°00'E., 75 feet to the Northwest Corner (Cor. No. 1).
