## CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

THIS IS TO CERTIFY that the JJ No. 71 lode mining claim was located by:

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 3, Township 26 North, Range 32 East, Mount Diablo Base and Meridian, thence North, approximately 922 feet and West, approximately 1232 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,490 feet from the location monument in a Southerly direction and 10 feet in a Northerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, S. 90° 00' E., 600 feet to the Northeast Corner (Cor. No. 2),  
thence, S. 00° 00' W., 750 feet to the East Side Center (Cor. No. 3),  
thence, S. 00° 00' W., 740 feet to the Southeast Corner (Cor. No. 4),  
thence, N. 89° 00' W., 600 feet to the Southwest Corner (Cor. No. 5),  
thence, N. 00° 00' E., 729 feet to the West Side Center (Cor. No. 6),  
thence, N. 00° 00' E., 750 feet to the Northwest Corner (Cor. No. 1),  
the point and place of beginning.

The monumentation and marking of the corners was completed by the 30th day of August, 1988.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
