AMENDED DEED OF GIFT

1 THIS INDENTURE, MADE AND ENTERED into this ___ day of October,
2 One Thousand Nine Hundred and Eighty Eight, BY and BETWEEN, J. DONALD
3 MORRISON, and ROSE V. MORRISON, his wife, of the Town of Eureka, County
4 of Eureka, State of Nevada, PARTIES of the FIRST PART, and GWENDOLYN
5 M. THOMAS, AND CARLTON S. THOMAS, of the Town of Eureka, County of
6 Eureka, State of Nevada, PARTIES of the SECOND PART:

WITNESSETH

7 THAT, the said Parties of the FIRST PART, for and in consideration
8 of the LOVE and AFFECTION which, the said Parties of the FIRST PART,
9 have and bear unto the said Parties of the SECOND PART, does by these
10 presents, give, grant alien, and confirm unto the said Parties of the
11 SECOND PART, not as tenants, in common, but as JOINT TENANTS, with the
12 right of survivorship, all those certain lots, pieces or parcels of land
13 situate, lying, or being in the Town of Eureka, County of Eureka, State of
14 Nevada, particularly described as follows, to-wit:

15 Frame House, 1968 Marlette Mobile Home, Greenseal Lode Millsite, and/or
16 any other real or personal property which the said Parties of the FIRST PART,
17 may now have, or may acquire during their lifetime.

18 South one-half Of Lot Six (6); all of Lot Seven (7); and Lot Eight (8); in
19 Block Thirty-one (31); of the Town of Eureka, County of Eureka, State of
20 Nevada, and on record in the Office of the County Recorder, of the Town of
21 Eureka, County of Eureka, State of Nevada.

22 TOGETHER with all and singular, the tenements, hereditaments, and
23 thereunto belonging to, or anywise appertaining, and the reversion, and the
24 reversions, issues and profits thereof.

25 TO HAVE and TO HOLD, all the said premises, TOGETHER with the appur-
26 tenances unto the said PARTIES of the SECOND PART, as JOINT TENANTS, and
27 to the Survivorship of them.
