Summary Report

September 1, 1988

This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the W. D. No. 1 through No. 20, a contiguous group of 20 lode mining claims situated in the Beowawe Mining District, Eureka County, Nevada.

The work consisted of reconnaisance geological mapping and geochemical sampling of the entire claim group, to evaluate the discovery of valuable mineral deposits located thereon and to assist in planning further exploration and development work. The work was performed on various dates and during various periods of time between the first day of September, 1987, and the first day of September, 1988, by or under the direct supervision of Andy Markos, 260 Coney Island Drive, Sparks, Nevada, 89431, a geologist of 12 years experience in exploration with a degree from University of Nevada-Reno (M.S., Geology, 1985).

The cost of the geological-geochemical study exceeded \$2,000.00 and was paid for by J.D. Welsh and Associates, owners of the subject sining claims.
