CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

ECM, Incorporated, by and through its lawful and authorized agent, Patrick C. Cavanaugh, gives notice that it claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing its rights, states and certifies as follows:

1. The name of the claim is Nessa 76.
2. The name and current mailing address of the locator is ECM, Incorporated, 2720 3rd Ave. North, Suite 450, Billings, MT 59101.
3. The date of location is July 2, 1988.
4. The claim is 1500 feet long and 600 feet wide, such that 25 feet is claimed in a East direction and 1475 feet in a West direction from the discovery monument, and which the Location Notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is East/West as nearly as may be determined.
5. The location work consisted of making maps as provided by NRS 517.040.

7. The Northeast Corner of this claim bears 10784 feet S, and 13070 feet E from the SW corner of Section 18, T 21 N, R 51 E, M.D.M.
8. This claim is located within the: NE 1/4 Section 9, T 21 N, R 50 E; and NW 1/4 Sec 10, T 21 N, R 50 E.
