The work consisted of drilling. The work described above was performed at the following locations: Hither 0 17, 18, 19, 20, and 22.

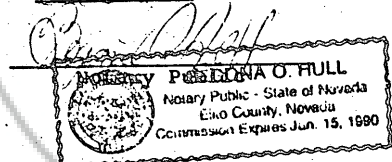
