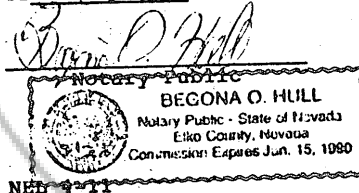

EXHIBIT A  
SUMMARY REPORT

This detailed report is filled in compliance with the requirements of Title 30, United States Code, Section 28-1 for the Dunphy, Nos. 1 - 5, a contiguous group of five (5) unpatented mining claims situated in Eureka County, State of Nevada, as described in Exhibit B, attached hereto.

The work consisted of recording geological data and geochemical sampling within the boundary of the Dunphy Nos. 4 and 5 claims. The work was performed on August 25, 1988, under the supervision of Robert R. Craig of 234 West Ash Street, Elko, Nevada, a professional geologist employed by Newmont Exploration Limited. Mr. Craig has a Masters of Science degree in geology and has been a practicing geologist for over ten years.

The geochemical work consisted of eighteen soil samples. These soil samples were used to evaluate the mineral potential within the claim group.

The cost of the work exceeded \$600.00 and was conducted at the expense of Newmont Exploration Limited.

The basic findings of these geological and geochemical studies indicate that geologic factors similar to other known mineralized properties in the region occur within the boundaries of the subject mining claims.

All technical work and results are in the possession of Newmont Exploration Limited, the owner of the subject claims.
