ASSUMPTION AGREEMENT


TO: FIRST AMERICAN TITLE COMPANY OF NEVADA, Trustee, and THE FIRST



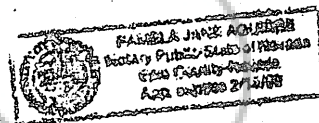
