AFFIDAVIT OF ANNUAL ASSESSMENT WORK

The undersigned, Robert M. Dahl, certifies that at least One Hundred Dollars (\$100) per claim was expended for development, labor and improvements as the annual assessment work for the assessment year ending September 1, 1988 for the following group of unpatented mining claims generally located in Sections 3, 8, 9, 15, 16, T.24N., R.49E., MDBM, Eureka County, Nevada:

Such expenditure was made by Noranda Exploration, Inc., the owner of the claims.

The work and improvements consisted of an Induced Polarization Geophysical Survey within the boundaries of the claim block. A total of 96 resistivity observations were made at 250 foot intervals along the five survey lines which are depicted on Exhibit "A".

Said work was performed between August 21, 1988 and August 29, 1988. A total of Seven Thousand Seven Hundred Thirty Dollars (\$7,730) was expended in performing the work and was done by an employee of Noranda Exploration, Inc., P. O. Box 7176, Reno, Nevada 89502, and a contractor who are qualified to perform such work:

The basic findings of the above work is as follows: The patterns of high and low resistivity which were determined upon interpretation of the field data form anomalies within the area of the claim block. These anomalies when correlated with the structural geology, rock types, and mineral occurrences in the area suggest further and more extensive development of each and all the claims. Selection of drill targets is being considered. The interpretations of the data and maps derived from the survey are on file in the offices of Noranda Exploration, Inc., P. O. Box 7176, Reno, Nevada.

All of the aforesaid claims form one contiguous group of claims and work on, or for the benefit of, any one claim tends to develop all the claims. The work was performed for the purpose of developing the mineral potential of the claims and to maintain and hold the claims.

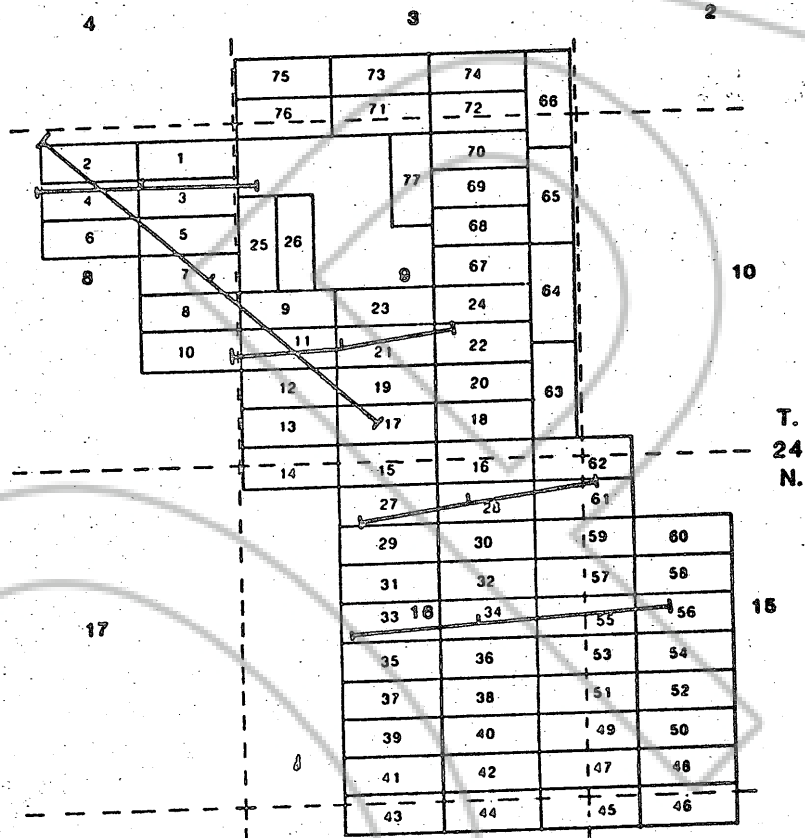
