The claim is approximately 1500 feet long and 600 feet wide, such that 1485 feet is claimed in a northerly direction and 15 feet in a southerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode is north-south.

The NW corner of this claim is located approximately

250 feet in a direction, thence

(200 feet in a M/25+ direction from the NE corner of Section 26, Township 19 North, Range 49 East, Mount Diablo Meridian.
