- 1.) Thomas J. Krause -- Cominco American Resources Inc., Buckhorn Operations., BS degree in Geology from Colorado State University, Fort Collins, CO., December, 1983.
- 2.) Wojtek A. Wodzicki -- Cominco American Resources Inc., Southwest Exploration Office, Sparks, NV., BS in Geology from Whitman College, Walla Walla, WA., August, 1985.
- 3.) North American Exploration Inc. -- Kaysville, UT., contract geologists, geochemists, samplers, field crews.

The survey work for the development of the claims was performed between May 1, 1988 and August 31, 1988, and consisted of:

- 1.) Taking shallow soil samples at grid points spaced 600' x 750'.
- 2.) Having full geochemical and fire assays performed on each sample.
- 3.) Preparation of maps showing geochemical survey information obtained.
- 4.) Preparation of map showing geological survey information obtained.

Such work cost, and is valued at, in excess of \$14,100.00.

As a result of the geological and geochemical surveys conducted, it has been determined gold, silver, and arsenic in soil outline areas of gold mineralization, and are coincident with hydrothermal alteration and fault/fracture intersections.

All of the aforementioned 141 unpatented lode mining claims are contiguous and work on any one claim or group of claims tends to develop all the claims. The work was performed for the purpose of developing the mineral potential of the claims, and to maintain and hold such claims.

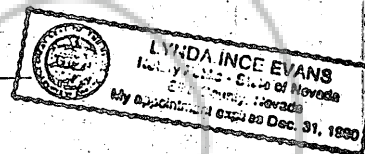
