The assessment work consisted of the following:

At least \$5,800.00 worth of labor or improvements consisting of the following were performed during the period of August 29, 1988 and August 31, 1988. Blackhawk Geosciences, Inc., whose address is 17301 West Colfax Avenue, Suite 150, Golden, Colorado 80401, was contracted to complete an electromagnetic survey. Survey work was supervised by Ray Lahit, a Geophysicist, employed by Blackhawk Geosciences, Inc.

Survey soundings are shown in Exhibit B.

Said work was performed for the purpose of delineating undiscovered sulfide bodies and alteration zones related to gold mineralization.

Several geologic targets, attributed to mineralization have been detected by the survey and will be drilling targets in 1989.

The assessment requirements for 1988 were fulfilled for the subject claim blocks.

Work was supervised by Tim Thamm, a minerals geologist, employed full-time by Billiton Minerals U.S.A., Inc., who has over five years experience in minerals exploration.
