DEED

W I T N E S S E T H:

That the Party of the First Part, for and in consideration of the sum of TEN (\$10.00) Dollars, current lawful money of the United State of America, to her in hand paid, and other good and valuable consideration, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell and convey and confirm unto the Party of the Second Part, and to her heirs, executors, administrators and assigns forever; in and to that certain real property situate in the Town of Eureka, County of Eureka, State of Nevada, and more particularly described as follows:

All of Lot Six (6), in Block Five (5), except twelve (12) inches of said Lot, as the same adjoins Lot Seven (7), in Block Five (5), all as more fully appears in the Bargain and Sale Deed, executed by G.B. Biale to Edward M. Thayer, Book 24 of Deeds, Page 178, File No. 29232, recorded in the Office of the County Recorder, Eureka County, Nevada; and also all that Southern part of Lot Five (5), in Block Five (5), which is more particularly described as follows, to-wit:
