Stanford R. Mahoney, being first duly sworn and according to law deposes and says that he is a citizen of the United States, of age, and resides in Salt Lake County, Utah. Affiant is an officer of Arroyo Minerals, Inc., owner of the below enumerated Lyndall mining claims described in Exhibit A attached hereto and made a part hereof, referred to as the "Subject Claims", which claims are contiguous, and which are situated in Eureka County, Nevada in unsurveyed lands, which, when surveyed according to protraction diagram, would probably be in Sections 27 and 34, T. 23N., R. 50E., MDB&M.

Affiant states that at least One Thousand and no/100 Dollars (\$1,000.00) worth of labor was performed and improvements made during the assessment year beginning at 12:00 noon of the first day of September, 1987, and ending on 12:00 noon of the first day of September 1988 upon and for the benefit of the Subject Claims, being not less than One Hundred Dollars (\$100.00) for each and every claim. Such labor included drilling, geological and geochemical sampling and mapping work physically performed on essentially all parts of the Lyndall 20, 22, 24, 37, 38, 39, 118, 119, 120 and 121 claims. The drilling activity by Brown Drilling Company was performed in the west central part of the Lyndall No. 39 claim, 150 feet east and 20 feet south of the west side center monument.

Such labor so performed and improvements made upon and for the benefit of the Subject Claims, includes, but is not limited to the above and attached descriptions of work performed. Reports, paid invoices and cost summaries are in corporate files.


The Subject Claims as more particularly described on Exhibit A, are part of a contiguous group of mining claims, as aforesaid. Said work was for the benefit of all of the Subject Claims as a part of a common plan of development and tends to improve and permit the development of each of the Subject Claims for which this Proof of Labor is being filed.

Such labor and improvements as described herein include 100 feet of drilling on a mineralized outcrop on the Lyndall No. 39 claim. Other work, including detailed mapping and channel sampling of mineralized outcrops, geologic and geochemical mapping by Melvin J. Pack, consulting geologist, and Albert E. Brown, on all portions of the Subject Claims, but more extensively on drilling and sampling of No. 39 is for the benefit of contiguous claims group Lyndall 20, 22, 24, 37, 38, 39, 118, 119, 120, 121. This work was accomplished in July 1988. A continuing evaluation and compilation of results of field work is being performed at date of this Proof in the offices of the Corporation and by consulting geologist Stanford R. Mahoney.

Such work actually performed on the Subject Claims was performed at a contractual cost of One Thousand Five Hundred and no/100 Dollars (\$1,500).

Such expenditure was made and performed by Arroyo Minerals, Inc., a Utah Corporation, 5926 Brentwood Drive, Salt Lake City, Utah 84121, for the purpose of complying with the laws of the United States (30 U.S.C. §28) and of the State of Nevada, pertaining to annual assessment.




