This is to certify that the HCS 168 lode mining claim was located by:

and

3000 feet N. 87 deg 53' 19" W.

to the northeast corner of the claim.

On claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 50 feet from the location monument in a N. 2 deg 5' 41" E. direction and 1450 feet in a S. 2 deg 5' 41" W. direction, together with 200 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by 3" diameter white PVC posts firmly set in the ground bearing applicable monument designation.

The claim boundary is as follows:

Beginning at the Northeast corner, #1, thence 750 feet S. 2 deg 5' 41" W. to the East side center, #2, thence 750 feet S. 2 deg 5' 41" W. to the Southeast corner, #3, thence 600 feet N. 87 deg 53' 19" W. to the Southwest corner, #4, thence 750 feet N. 2 deg 5' 41" E. to the West side center, #5, thence 750 feet N. 2 deg 5' 41" E. to the Northwest corner, #6, thence 600 feet S. 87 deg 53' 19" E. to the Northeast corner, #1, the point of beginning.

The monumentation and marking of the corners was completed by August 25, 1988.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the Eureka County Recorder.
