

CERTIFICATE OF LOCATION

This is to certify that the HCS 215 lode mining claim was located by:

To tie this claim to the Public Survey, begin at the northwest corner of Section 1, T. 25 N., R. 49 1/2 E., M.D.M.; thence, 2826 feet N. 2 deg 6' 41" E. and 1500 feet S. 87 deg 53' 19" E. to the northeast corner of the claim.

We claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1480 feet from the location monument in a S. 87 deg 53' 19" E. direction and 20 feet in a N. 87 deg 53' 19" W. direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by 3" diameter white PVC posts firmly set in the ground bearing applicable monument designation.

The claim boundary is as follows:

Beginning at the Northeast corner, #1, thence 500 feet S. 2 deg 6' 41" E. to the Southeast corner, #2, thence 750 feet N. 87 deg 53' 19" W. to the South side center, #3, thence 750 feet N. 87 deg 53' 19" W. to the Southwest corner, #4, thence 600 feet N. 2 deg 6' 41" E. to the Northwest corner, #5, thence 750 feet S. 87 deg 53' 19" E. to the North side center, #6, thence 750 feet S. 87 deg 53' 19" E. to the Northeast corner, #1, the point of beginning.

The monumentation and marking of the corners was completed by August 25, 1988.

The location work consisted of making a claim map as provided, SRS 512 6401. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the Eureka County Recorder.
