## CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and mailing address of 5011 Meadowood Way, Suite 200, Reno, Nevada, 89502, has located the

lode mining claim this 29th day of September, 1988, under and by the virtue of the mining laws and regulations of the United States and the State of Nevada.
