lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SE corner located about 300' east from the monument of location, thence 750 feet in a Northerly direction to a Eastside center post marked, thence 750 feet in a Northerly direction to a corner post marked NE corner, thence 600 feet in a Westerly direction to a corner post marked NW corner, thence 750 feet in a Southeasterly direction to a post marked Westside Center, thence 750 feet in a Southerly direction to a corner post marked SW corner, thence 600 feet in a Easterly direction to the SE corner hereby locating and intending to claim 1450 feet in a northerly direction from monument of location to the north end line, and 50 feet in the opposite direction from discovery to the south


