CONFIRMATION DEED

This Confirmation Deed is made on the <u>26</u> day of <u>October</u>, 1988, by and between <u>CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS</u>, a Utah Corporation Sole (hereinafter referred to as "Grantor") and SIERRA PACIFIC POWER COMPANY, a Nevada corporation, (hereinafter collectively referred to as "Grantee").

## RECITALS

1. Grantor conveyed to Grantee by Grant of Easement dated <u>February 23, 1988</u>, and recorded as File No. <u>000 68781</u>, on <u>March 29, 1988</u>, in the Office of the County Recorder, Carson City, Nevada, a copy of which is attached hereto and incorporated herein by reference as Exhibit "A".

2. In Exhibit "A", by mistake, in the heading of the Grant of Basement for Electric Transmission and Distribution, the name of the Grantor was inadvertently written as "CORPORATION OF THE PRESIDENT, CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS." The correct name of the Grantor should read and does read above correctly as CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS, a Utah Corporation Sole. The correction above was in fact intended by the parties and would adequately express the agreement between them.

3. To prevent difficulties hereafter, and to permit recordation of a deed which reflects the true agreement of the parties in every respect, the parties desire to correct these errors.
