CONFIRMATION DEED

This Confirmation Deed is made on the 26 day of October, 1988, by and between CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS, a Utah Corporation Sole (hereinafter referred to as "Grantor") and SIERRA PACIFIC POWER COMPANY, a Nevada corporation, (hereinafter collectively referred to as "Grantee").

RECITALS

1. Grantor conveyed to Grantee by Grant of Easement dated February 23, 1988, and recorded as File No. 000 68781, on March 29, 1988, in the Office of the County Recorder, Carson City, Nevada, a copy of which is attached hereto and incorporated herein by reference as Exhibit "A".
2. In Exhibit "A", by mistake, in the heading of the Grant of Easement for Electric Transmission and Distribution, the name of the Grantor was inadvertently written as "CORPORATION OF THE PRESIDENT, CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS." The correct name of the Grantor should read and does read above correctly as CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS, a Utah Corporation Sole. The correction above was in fact intended by the parties and would adequately express the agreement between them.
3. To prevent difficulties hereafter, and to permit recordation of a deed which reflects the true agreement of the parties in every respect, the parties desire to correct these errors.

CONFIRMATION OF CONVEYANCE

THEREFORE THIS INSTRUMENT WITNESSETH:

That Grantor, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby grant to Grantee, its successors and assigns forever the following described property situate in the County of Carson City, State of Nevada, to wit:

A portion of Section 16, Township 15 North, Range 20 East, M.D.B.&M., Carson City, Nevada.

PARCEL NO. 1

An exclusive and permanent easement to Sierra Pacific Power Company being more particularly described as follows:

The Westerly 17.5 feet of "Parcel A" as shown on the "Parcel Map for Eva Lompa, Parcel Map No. 2", File No. 82033, filed August 31, 1978, Official Records of Carson City, Nevada.

PARCEL NO. 2

A public utility easement being more particularly described as follows:

The Westerly 25.0 feet of "Parcel A" as described in Parcel No. 1, hereinabove EXCEPTING THEREFROM the Westerly 17.5 feet.

Easement boundaries are to be forelengthened or foreshortened to meet property lines of the Grantor.
