CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 32, Township 27 North, Range 48 East, Mount Diablo Base and Meridian, thence North, approximately 1,946 feet and East, approximately 8,364 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,450 feet from the location monument in a Northeasterly direction and 50 feet in a Southwesterly direction, together with 150 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, S.66°00'W., 750 feet to the South Side Center (Cor. No. 5).

thence, S.66°00'W., 750 feet to the Southwest Corner (Cor. No. 6).

thence, N.16°00'E., 300 feet to the Northwest Corner (Cor. No. 1).

The monumentation and marking of the corners was completed by the 3rd day of November, 1988.
