

CERTIFICATE OF LOCATION FOR LORE MINING CLAIM

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 32, Township 27 North, Range 48 East, Mount Diablo Base and Meridian, thence North, approximately 6,721 feet and East, approximately 10,130 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,275 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,265 feet from the location monument in a Southerly direction and 10 feet in a Northerly direction, together with 250 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, N. 90°00'E., 500 feet to the Northeast Corner (Cor. No. 2).
thence, S. 00°00'E., 637.5 feet to the East Side Center (Cor. No. 3).
thence, S. 00°00'E., 637.5 feet to the Southeast Corner (Cor. No. 4).
thence, S. 90°00'W., 500 feet to the Southwest Corner (Cor. No. 5).
thence, N. 00°00'W., 637.5 feet to the West Side Center (Cor. No. 6).
thence, N. 00°00'W., 637.5 feet to the Northwest Corner (Cor. No. 1).
the point and place of beginning.

The monumentation and marking of the corners was completed by the 3rd day of November, 1988.
