

CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

We (or I) claim 1,275 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,265 feet from the location monument in a Southerly direction and 10 feet in a Northerly direction, together with 250 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, S. 90°00'W., 500 feet to the Southwest Corner (Cor. No. 5).

thence, N. 00°00'W., 637.5 feet to the Northwest Corner (Cor. No. 1).
