CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

We (or I) claim 150 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 75 feet from the location monument in a Northwesterly direction and 75 feet in a Southeasterly direction, together with 75 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

the point and place of beginning.
