CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

We (or I) claim 450 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 350 feet from the location monument in a Southeasterly direction and 100 feet in a Northwesterly direction, together with 110 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:
