CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 32, Township 27 North, Range 48 East, Mount Diablo Base and Meridian, thence North, approximately 11,802 feet and East, approximately 7,935 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 800 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 550 feet from the location monument in a Southeasterly direction and 250 feet in a Northwesterly direction, together with 175 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, S. 59°00'E., 400 feet to the North Side Center (Cor. No. 2),
thence, S. 59°00'E., 400 feet to the Northeast Corner (Cor. No. 3),
thence, S. 31°00'W., 350 feet to the Southeast Corner (Cor. No. 4),
thence, N. 59°00'W., 400 feet to the South Side Center (Cor. No. 5),
thence, N. 59°00'W., 400 feet to the Southwest Corner (Cor. No. 6),
thence, N. 31°00'E., 350 feet to the Northwest Corner (Cor. No. 1),
the point and place of beginning.

The monumentation and marking of the corners was completed by the 3rd day of November, 1988.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
