We (or I) claim 100 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 50 feet from the location monument in a Southeasterly direction and 50 feet in a Northwesterly direction, together with 50 feet on each side of the center of the ledge for the entire length of the claim.
