We (or I) claim 550 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 400 feet from the location monument in a Southeasterly direction and 150 feet in a Northwesterly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, N.19°00'W., 275 feet to the West Side Center (Cor. No. 6).
thence, N.19°00'W., 275 feet to the Northwest Corner (Cor. No. 1).
