CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 32, Township 27 North, Range 48 East, Mount Diablo Base and Meridian, thence North, approximately 15,096 feet and East, approximately 5,250 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,050 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 525 feet from the location monument in a Southeasterly direction and 525 feet in a Northwesterly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:
