We (or I) claim 1,400 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,390 feet from the location monument in a Northwesterly direction and 10 feet in a Southeasterly direction, together with 150 feet on each side of the center of the ledge for the entire length of the claim.
