CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 32, Township 27 North, Range 48 East, Mount Diablo Base and Meridian, thence North, approximately 11,915 feet and East, approximately 4,684 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 400 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 325 feet from the location monument in a North-easterly direction and 75 feet in a Southwesterly direction, together with 225 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

thence, N. 12°00'E., 200 feet to the Northwest Corner (Cor. No. 1),

the point and place of beginning.
