

CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

THIS IS TO CERTIFY that the PHIL No. 26 lode mining claim was located by:

SW 1/4 of Section 20, Township 27 N., Range 48 E., M.D.B. & M.

SE 1/4 of Section 20, Township 27 N., Range 48 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 32, Township 27 North, Range 48 East, Mount Diablo Base and Meridian, thence North, approximately 14,889 feet and East, approximately 2,688 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 800 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 400 feet from the location monument in a Northwesterly direction and 400 feet in a Southeasterly direction, together with 200 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, S. 75°00'E., 400 feet to the North Side Center (Cor. No. 2),

thence, S. 75°00'E., 400 feet to the Northeast Corner (Cor. No. 3),

thence, S. 15°00'W., 400 feet to the Southeast Corner (Cor. No. 4),

thence, N. 75°00'W., 400 feet to the South Side Center (Cor. No. 5),

thence, N. 75°00'W., 400 feet to the Southwest Corner (Cor. No. 6),

thence, N. 15°00'E., 400 feet to the Northwest Corner (Cor. No. 1),

the point and place of beginning.

The monumentation and marking of the corners was completed by the 3rd day of November, 1988.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
