

# CERTIFICATE OF LOCATION LODE MINING CLAIM

The claim is 1500 feet long and 600 feet wide, and 20 feet is claimed in a N7E 1/4 direction and 450 feet in a direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and the premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by 3"x 5" aluminum tags attached to the posts with wire.

The description of each corner is as follows:

Corner No. 1 is a 3" diameter x 5' long P.V.C. post  
Corner No. 2 is a 3" diameter x 5' long P.V.C. post  
Corner No. 3 is a 3" diameter x 5' long P.V.C. post  
Corner No. 4 is a 3" diameter x 5' long P.V.C. post  
Corner No. 5 is a 3" diameter x 5' long P.V.C. post  
Corner No. 6 is a 3" diameter x 5' long P.V.C. post

The monumentation and marking of the corners was completed by the 25 day of October, 1988.

The location work consisted of making a map as provided in NRS 517.040. Two copies of this map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
