 Thence, 750 feet in a north direction to Post No. 5, marked - AT 50 -5.

 Thence, 600 feet in an east direction to Post No. 1, marked - AT 50 -1.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

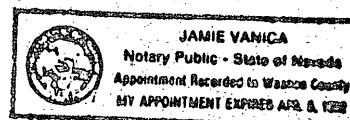
