KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the SOL. 418

lode mining claim this 20th day of November, 1988, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in N. 45° W. direction and 10 feet in a S. 45° E. direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To tie this claim to the Public Survey, begin at the Northeast Corner, Section 1, T. 19 N., R. 50 E., Mt. Diablo P.M., and bear N. 45° W. 4700 feet, and N. 45° E. 14,000 feet, to the northeast corner of this claim.


Mt. Diablo P.M., Unknown Mining District, Eureka County, Nevada.

The location monument, corners and side centers are 3" x 4" durable plastic pipe, set one foot in the ground or mound of stone. The location and markings on each corner or side center are more particularly described as follows:

Beginning at the northeast corner post No. 1,
Thence, 600 feet S. 45° W. to Post No. 2, the Southeast Corner
Thence, .750 feet N. 45° W. to Post No. 3, the South Side Center
Thence, .750 feet N. 45° W. to Post No. 4, the Southwest Corner
Thence, .600 feet N. 45° E. to Post No. 5, the Northwest Corner
Thence, .750 feet S. 45° E. to Post No. 6, the North Side Center
Thence, .750 feet S. 45° E. to Post No. 1, the Northeast Corner


