SEC 4 T23N R50E MDM. FROM THIS DISCOVERY MONUMENT, THE
UNDERSIGNED CLAIMS 10 FEET IN AN NORTH DIRECTION, AND, 1990
FEET IN A SOUTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
