SEC 4 T23N R50E MDM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 18 FEET IN AN/AN SOUTH DIRECTION, AND, 1490  
FEET IN A/AN NORTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
