CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the BASS 261

lode mining claim this 2nd day of December, 1988, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To tie this claim to the Public Survey, begin at the Northeast Corner, Section 12, T. 18 N., R. 52 E., Mt. Diablo P.M., and bear south 4271 feet, and west 12,580 feet, to the northeast corner of this claim.
