KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the BASS 278

Lode mining claim this 2nd day of December, 1988, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.
