CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that PMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the BASS 279

lode mining claim this 2nd day of December, 1988, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To tie this claim to the Public Survey, begin at the northeast corner, Section 12, T. 18 N., R. 52 E., Mt. Diablo P.M., and bear south 4271 feet, and west 7180 feet, to the northeast corner of this claim.

The general course of strike of the vein or lode as near as may be determined is north and south.

The location monument, corners and side centers are 3" x 4" durable plastic pipe, set one foot in the ground or mound of stone. The location and markings on each corner or side center are more particularly described as follows:

Thence, 750 feet south to Post No. 3, the southeast corner BASS 279 -3

Thence, 750 feet north to Post No. 5, the west side corner BASS 279 -5
Thence, 750 feet north to Post No. 6, the northwest corner BASS 279 -6
Thence, 600 feet east to Post No. 1, the northeast corner BASS 279 -1

The point of beginning, the monumentation and marking of the corners was completed by the 5th day of December, 1988.
