

CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 282 lode mining claim was located by:

Said claim is located in the NE/4 of Sec. 23, Twp. 33 North, Range 50 East.
SE/4 of Sec. 25, Twp. 33 North, Range 50 East.
NW/4 of Sec. 25, Twp. 33 North, Range 50 East.
SW/4 of Sec. 24, Twp. 33 North, Range 50 East.

To tie this claim to the Public Survey, begin at the NE corner of Section
23, Township 33 North, Range 50 East, Mount Diablo Meridian,
thence 4200 feet S and 200 feet E to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 50 feet from the location monument in a N direction
and 1450 feet in a S direction, together with 100 feet
on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe
monuments firmly set in the ground and bearing applicable monument designation. The
description of such claim is: Beginning at the Northeast Corner:

thence, <u>W</u> , <u>200</u> feet to the <u>NW</u> corner,
thence, <u>S</u> , <u>750</u> feet to the <u>W</u> side center,
thence, <u>S</u> , <u>750</u> feet to the <u>SW</u> corner,
thence, <u>E</u> , <u>200</u> feet to the <u>SE</u> corner,
thence, <u>N</u> , <u>750</u> feet to the <u>E</u> side center,
thence, <u>N</u> , <u>750</u> feet to the <u>NE</u> corner,

the point and place of beginning.

The monumentation and marking of the corners was completed by the 26 day of
OCT., 1988.

the lode claim filing fee has been paid to the County Recorder.
