CERTIFICATE OF LOCATION
LODE CLAIM

THIS IS TO CERTIFY that the CT # 288 lode mining claim was located by:

Said claim is located in the NE/4 of Sec. 36, Twp. 33 North, Range 50 East.
SE/4 of Sec. 36, Twp. 33 North, Range 50 East.
NW/4 of Sec. 36, Twp. 33 North, Range 50 East.
SW/4 of Sec. 36, Twp. 33 North, Range 50 East.

To tie this claim to the Public Survey, begin at the NW corner of Section
36, Township 33 North, Range 50 East, Mount Diablo Meridian,
thence 1500 feet E and 3000 feet S to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 50 feet from the location monument in a W direction
and 1450 feet in a E direction, together with 300 feet
on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe
monuments firmly set in the ground and bearing applicable monument designation. The
description of such claim is: Beginning at the Northeast Corner:
