## CERTIFICATE OF LOCATION

## LODE CLAIM

THIS IS TO CERTIFY that the CT # 300 lode mining claim was located by:

St. George Metals, Inc.

on the 10 day of Nov., 1988, situated in the undesignated Mining District,  
Eureka County, State of Nevada.

Said claim is located in the NE/4 of Sec. 34, Twp. 33, Range 50, East 50.  
SE/4 of Sec. 34, Twp. 33, Range 50, East 50.  
NW/4 of Sec. 34, Twp. 33, Range 50, East 50.  
SW/4 of Sec. 34, Twp. 33, Range 50, East 50.

To tie this claim to the Public Survey, begin at the SW corner of Section 34, Township 33, North, Range 50, East, Mount Diablo Meridian, thence 5280 feet N and 600 feet E to the Northeast corner of this claim.

We (or I) claim 780 linear feet along the course of the ledge, lode or vein, extending 50 feet from the location monument in a S direction and 730 feet in a N direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, <u>N</u>	<u>390</u>	feet to the <u>NE</u> corner,

the point and place of beginning.

The monumentation and marking of the corners was completed by the 7 day of Jan., 1989.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
